

# Bentley Education Network

This Bentley Academic Network Agreement (the "Agreement" or the "BEN Agreement") is made as of the Effective Date by and between Bentley Systems, Incorporated, a Delaware corporation with its principal place of business at 685 Stockton Drive, Exton, Pennsylvania 19341, and Subscriber identified on the cover of this BEN Agreement ("Subscriber").

**Grant of License.** Bentley hereby grants to Subscriber a non-exclusive right and license to use in object code form the number of copies of the software noted and the period described on the cover of this Agreement ("License Term"). Subscriber shall, in accordance with the procedures prescribed by Bentley from time to time, assign to and embed in the software the serial number provided to Subscriber by Bentley. Subscriber recognizes that the software licensed hereunder is not licensed on a perpetual basis and is provided to Subscriber for use only for the applicable License Term. The software will be delivered to Subscriber with embedded time clocks, copy protection mechanisms, or other security devices that may deactivate the software after the expiration of the License Term ("Time Clocks"). Subscriber agrees that Time clocks are not defects of the software and hereby releases Bentley from any and all claims, however characterized, arising from or relating to the Time Clocks or their operation. Transfer of these license rights granted to Subscriber or the obligations of Subscriber to a third party is expressly prohibited.

**Academic Use.** The license granted is for Academic Use only, and the rights of production, distribution, manufacture, sale, or otherwise transfer the licensed software to third parties is expressly prohibited. "Academic Use" means the use of a Bentley Product in Object Code from solely for internal academic purposes including instruction and research excluding timesharing (i.e. allowing multiple concurrent users to have access to one (1) copy of a Product), student use in a paid-employment setting, service bureau or facilities management use. Subscriber is responsible for regulating and recording access to the licensed software used by Subscriber and its students. Bentley reserves the right to audit Subscriber's software and license access records during the term of this Agreement for compliance with licensing regulations. Subscriber should submit any questions about the license and its responsibilities in tracking access to its designated MVAR, identified on the cover page of this Agreement.

**Bentley Education Network CSP.** shall consist of periodic distribution to Subscriber of upgrades and updates as and when published by Bentley during the License Term and access to SELECTservices Online (the terms and conditions of use of SELECTservices Online are set forth from time to time on the Internet site).

**Fees.** Subscriber shall pay to Bentley the applicable fee for the software as indicated on the cover page of this Agreement. The specified fees shall include the licensor(s) as well as the Bentley Education Network CSP. Subscriber shall pay each Bentley invoice hereunder within thirty (30) days from the date of such invoice. Interest shall accrue on delinquent payments of such invoices at the rate of one and one-half percent (1.5%) per month or the highest rate permitted by applicable law, whichever is less. In the event payment of such invoices is past due, Bentley, at its discretion, may suspend Subscriber's rights hereunder to use the software or receive services until full payment is made. Subscriber shall be responsible for the payment of any and all applicable taxes, including but not limited to sales, use, occupation, value added, excise, and property taxes (except for taxes based on Bentley's net income).

**Intellectual Property Rights.** The software, including the document sets, and any information which Subscriber obtains through the Bentley Education Network CSP or the use of SELECTservices Online, contain proprietary information of Bentley, its licensors or other suppliers, and are protected under United States copyright laws, other applicable copyright laws, other laws relating to the protection of intellectual property, and international treaty provisions. The entire right, title and interest in and to the software and related documentation, any information Subscriber obtains through Bentley Education Network CSP or the use of SELECTservices Online, and all associated intellectual property rights, shall remain with Bentley or its licensors. The software licensed hereunder is licensed, not sold, and title to each copy of the software shall remain with Bentley or its licensors, and shall not pass to Subscriber. Bentley retains all rights not expressly granted. Subscriber shall have no right hereunder to receive, review, use or otherwise have access to the source code for the software. Subscriber shall reproduce and include on all copies of the software created by Subscriber all copyright notices and proprietary legends of Bentley or its licensors as they appear in or on the original media containing the software supplied by Bentley. Subscriber shall not translate, decode, disassemble, decompile, alter, reverse engineer or create derivative works from the software or use the software to develop functionally similar computer software. Subscriber understands and agrees that Bentley may, in connection with the provision of software and services hereunder, disclose to Subscriber confidential, proprietary and technical information pertaining to Bentley's technology and business practices (collectively "Proprietary Information"). Subscriber shall maintain the confidentiality of all Proprietary Information. Subscriber shall not reproduce or copy Proprietary Information except as permitted in this Agreement or as may be expressly authorized in writing in advance by Bentley. Subscriber shall not disclose or make Proprietary Information available to any third party at any time. Upon the termination of this Agreement, Subscriber shall return to Bentley or, if so requested, destroy all Proprietary Information in its possession. Subscriber may not disclose the results of any product testing, including but not limited to benchmarks, to any third party without first obtaining Bentley's written consent to do so. The terms of paragraph shall survive the termination of this Agreement.

**Warranty Remedies Liability.** Bentley hereby warrants for the benefit only of BEN Subscribers that (a) for a period of ninety (90) days ("Warranty Period") from the date of delivery to Subscriber of a serial number, the software shall, under normal use, operate in substantial conformance with the functional specifications set forth in the document set applicable to such software. If any modifications, enhancements or changes are made by Subscriber to the software; if the software is reverse-engineered, decompiled or disassembled; or if Subscriber breaches the terms of this Agreement, then the warranties in this paragraph shall be immediately terminated. This limited warranty gives Subscriber specific legal rights. Subscriber may have other rights, which may vary from state/jurisdiction to state/jurisdiction. THE WARRANTIES STATED IN THIS PARAGRAPH ARE BENTLEY'S SOLE AND EXCLUSIVE WARRANTIES PERTAINING TO THE SOFTWARE AND OTHER MATERIALS AND SERVICES LICENSED, DELIVERED OR OTHER-

WISE FURNISHED BY BENTLEY UNDER THIS AGREEMENT. BENTLEY DOES NOT WARRANT THAT THE SOFTWARE OR ANY OTHER SERVICE OR MATERIALS WILL MEET SUBSCRIBER'S REQUIREMENTS, BE FREE FROM VIRUSES OR OPERATE UNINTERRUPTED OR ERROR FREE. BENTLEY HEREBY DISCLAIMS ALL OTHER WARRANTIES, EITHER STATUTORY, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION, WARRANTIES AGAINST NON-INFRINGEMENT AND THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THESE EXCLUSIONS MAY NOT APPLY TO SUBSCRIBER, AS SOME STATES/JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF CERTAIN WARRANTIES. The entire liability of Bentley and the sole and exclusive remedy of Subscriber shall be, in Bentley's sole and absolute discretion, (i) to repair or replace software or other materials in breach of the foregoing warranties, (ii) to advise Subscriber how to achieve the same functionality with the software as described in the document set through a procedure different from that set forth in the document set, or (iii) to return the purchase price or fees paid therefore, where written notice of such breach, specifying the defect, is furnished to Bentley during the Warranty Period. Bentley shall pay any damages finally awarded against Subscriber based on a claim against Subscriber that the software infringes a third party's United States copyright, if Subscriber provides to Bentley prompt written notice of any such claim, all available information and assistance, and the opportunity to exercise sole control of the defense and all negotiations pertaining to such claim. Bentley shall also have the right, at its expense, either to procure the right for Subscriber to continue to use the software or to replace or modify the software so that it becomes non-infringing. If neither of the foregoing alternatives is available on terms that Bentley, in its sole discretion, deems desirable, Subscriber shall, upon written request from Bentley, return to Bentley the allegedly infringing software, in which event Bentley shall refund to Subscriber the price paid by Subscriber. This provision shall not apply if the alleged infringement is due to modification of the software by Subscriber or the combination, operation or use of the software with other software that does not originate from Bentley or if Subscriber is in breach of this Agreement. Bentley shall also have no liability, and this provision shall not apply, for the portion of any claim of infringement based on use of a superseded or altered release of the software if the infringement would have been avoided by the use of a current, unaltered release of the software. IN NO EVENT SHALL BENTLEY AND ITS LICENSORS AND SUPPLIERS BE LIABLE TO SUBSCRIBER FOR ANY INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, REGARDLESS OF THE NATURE OF THE CLAIM, INCLUDING WITHOUT LIMITATION LOST PROFITS, COSTS OF DELAY, INTERRUPTION OF BUSINESS, LOSS OF USE, INABILITY TO ACCESS ONLINE SERVICES, ANY FAILURE OF DELIVERY, COSTS OF LOST OR DAMAGED DATA OR DOCUMENTATION, OR LIABILITIES TO THIRD PARTIES ARISING FROM ANY SOURCE, EVEN IF BENTLEY HAS BEEN ADVISED, KNEW OR SHOULD HAVE KNOWN OF THE POSSIBILITY OF SUCH DAMAGES OR CLAIMS. BECAUSE SOME STATES AND/OR JURISDICTIONS DO NOT ALLOW FOR THE EXCLUSION OR LIMITATION OF LIABILITY FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES, THE ABOVE LIMITATION MAY NOT APPLY TO SUBSCRIBER. IN THE EVENT THAT BENTLEY IS FOUND LIABLE FOR DAMAGES BASED ON ANY BREACH, DEFECT, DEFICIENCY OR NON-CONFORMITY IN SOFTWARE OR IN ANY OTHER SERVICE OR MATERIALS, AND REGARDLESS OF WHETHER ANY REMEDY SET FORTH HEREIN FAILS OF ITS ESSENTIAL PURPOSE BY LAW, BENTLEY'S TOTAL LIABILITY SHALL NOT EXCEED THE PRICE PAID BY SUBSCRIBER HEREUNDER. THE PROVISIONS OF THIS AGREEMENT ALLOCATE THE RISKS BETWEEN BENTLEY AND SUBSCRIBER. BENTLEY'S PRICING REFLECTS THIS ALLOCATION OF RISK AND THE LIMITATION OF LIABILITY SPECIFIED HEREIN.

**Export Controls.** The software has been manufactured or developed in the United States of America and accordingly may be subject to U.S. export control laws, regulations and requirements. Subscriber must not export or transfer, whether directly or indirectly, the software, or any portion thereof, or any system containing the software Products or portion thereof, to anyone outside the United States (including further export if Subscriber took delivery of the software outside the United States) without first complying strictly and fully with all export controls that may be imposed on the Products by the United States Government or any country or organization of nations within whose jurisdiction Subscriber uses the Products.

**Miscellaneous.** Bentley shall not be liable for failure to fulfill the terms of this Agreement due to causes that are beyond its control. The failure of either party to insist upon any of its rights hereunder shall not be deemed a waiver of other rights. The terms of this Agreement which, by their nature, require performance of the parties after the expiration of this Agreement shall be enforceable notwithstanding such expiration. The provisions of this Agreement shall be severable and the invalidity or enforceability of one provision shall not affect any other. Bentley's relationship with Subscriber shall be that of an independent contractor. All notices pertaining to this Agreement, including but not limited to changes of ownership of Subscriber, changes of location, changes to the identifi(cies) of the authorized representatives, notices of dispute, and the like, shall be addressed to the authorized representative(s) identified on the cover page of this Agreement, and to Bentley's general counsel. Questions relating to the interpretation of specific terms outlined in this Agreement should be addressed to the Bentley representative identified on the cover page of this agreement, or to Bentley's Contract Administrator. Subscriber agrees all claims or disputes relating to this agreement shall be submitted for final, binding arbitration before a single arbitrator in accordance with the laws of Pennsylvania and within the jurisdiction of Phila., Pennsylvania and according to the Commercial Rules of Arbitration of the American Arbitration Association.

**Entire Agreement.** This Agreement contains the entire agreement of the parties and supersedes all prior oral or written understandings or agreements between the parties with respect to the subject matter hereof. The terms and conditions of this Agreement shall apply to each order accepted and shipped by Bentley hereunder. Amendments or modifications to this Agreement shall be in writing and duly executed by both parties.
