

## MAPLESOFT™ STUDENT LICENSE AGREEMENT

### IMPORTANT NOTICE: READ CAREFULLY BEFORE OPENING THIS SEALED PACKAGE

THE ENCLOSED SOFTWARE IS PROVIDED TO YOU UNDER THE FOLLOWING LICENSE AGREEMENT. THIS LICENSE AGREEMENT IS A LEGAL AGREEMENT BETWEEN YOU, (AN INDIVIDUAL CURRENTLY ENROLLED AT AN ACCREDITED EDUCATIONAL INSTITUTION) AS END USER AND LICENSEE, AND MAPLESOFT, A DIVISION OF WATERLOO MAPLE INC. ("MAPLESOFT"), AND DEFINES WHAT YOU MAY DO WITH THE SOFTWARE, AND WHAT LIMITATIONS EXIST ON WARRANTIES AND REMEDIES RELATED TO THE SOFTWARE. BY OPENING THIS SEALED PACKAGE, YOU BECOME A PARTY TO, AND AGREE TO BE BOUND BY ALL THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT. IF, AFTER READING THIS LICENSE AGREEMENT, YOU DO NOT ACCEPT OR AGREE TO THE TERMS AND CONDITIONS CONTAINED IN THIS LICENSE AGREEMENT, DO NOT OPEN THE SEALED PACKAGE. YOU MAY, WITHIN 15 DAYS OF PURCHASE, RETURN THE ENTIRE UNOPENED PACKAGE AND ALL OTHER ITEMS CONTAINED IN THIS BOX (INCLUDING THE PACKAGING), TOGETHER WITH YOUR RECEIPT TO THE PLACE WHERE YOU OBTAINED THEM FOR A FULL REFUND OF THE AMOUNT PAID FOR THE PACKAGE. NOTWITHSTANDING THE ABOVE, IF YOU OBTAINED THE PACKAGE FROM A PARTY OTHER THAN MAPLESOFT AND YOU RETURN THE PACKAGE WITHIN THE ABOVE STATED TIME PERIOD TO MAPLESOFT DIRECTLY, YOU WILL RECEIVE A REFUND IN THE AMOUNT OF THE WHOLESALE PRICE OF THE PRODUCT.

### STUDENT LICENSE AGREEMENT

#### OWNERSHIP OF SOFTWARE.

- Maplesoft owns (or has the right to sublicense) and retains all right, title and interest, including all copyrights and other intellectual property rights (whether or not patentable or registrable under copyright, trademark, or similar legislation or subject to analogous protection) in and to the MAPLE™ software, including, without limitation, all software and associated media, enhancements, improvements, corrections, and/or modifications to the Maple software (collectively, the "Software") as well as related printed materials, including the learning guide and/or programming guide (the "Printed Materials") contained in this package.
- Maplesoft does not sell any rights in the Software, but rather grants the right to use the Software by means of a software license.
- Maplesoft reserves all rights with respect to the Software and Printed Materials not expressly granted by this student license Agreement.
- You own only the physical media on which the Software is recorded or fixed in this package.
- The Software and Printed Materials are protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties.

#### GRANT OF LICENSE.

In consideration of payment of the student license fee, which is the student price you paid for this package, and your agreement to abide by the terms and conditions of this student license Agreement, Maplesoft, as licensor, grants to you a non-exclusive, revocable, personal, non-transferable license and right to use this copy of the Software (the "Student License") for as long as you are enrolled for educational purposes as a student ("Student") at an educational institution that been duly accredited by a widely-recognized accreditation authority as such and are using the Software for personal study purposes ("Study Use") only and not for other purposes, including but not limited to, commercial use. For greater certainty, purchase-

es of all Student Licenses are restricted to Students and no other person, firm, corporation or other entity shall be entitled to purchase the Student License. Should you no longer be a Student and/or should you no longer use the software for Study Use, you may continue to use the Software for personal use only, which shall not include use at your place of employment.

#### YOU MAY:

- Install and use this copy of the Software on a single computer at a single location, or physically transfer the Software from one computer to another (including permanently and completely deleting the Software from the first computer), provided the Software is used only by a single user on a single computer at one time. - Use the whole or any part of the Software as part of an Internet/Intranet/Extranet website or via other electronic communication distribution methods that facilitate access by a third party, unless the third party is a licensed user of the Software.
- Rent, lease, license, transfer, assign, sell or otherwise provide access to the Software or Printed Materials, in whole or in part, on a temporary or permanent basis, except as otherwise permitted by this License Agreement.
- Without limiting the restrictions set forth above, distribute any components of the Software for any reason including, without limitation, as part of a third party software application, without permission in writing from Maplesoft.
- Alter, remove or cover proprietary notices in or on the Software, Printed Materials or storage media.
- Purchase or use the Software for professional purposes or for purposes other than that described under "Grant of License" herein.
- Use the Software in any unlawful manner whatsoever.

#### SUPPORT SERVICE.

Maplesoft shall provide you, as part of the License, basic level support service as follows: 30 day Installation Support from date of installation, access to web resources (FAQs, Web form, technical support email) and access to patches and service packs.

#### TERM.

This Student License Agreement becomes effective upon your opening the sealed package, and is effective unless terminated earlier by Maplesoft for any reason upon 30 days prior written notice. Maplesoft may terminate this Student License Agreement without notice to you if you fail to comply with any provision of this Student License Agreement. Upon termination, you agree to immediately cease using the Software and Printed Materials and to return all copies of the Software and Printed Materials in your possession to Maplesoft within five days of termination. The Ownership of Software and Limited Warranty and Liability and Indemnity sections of this Student License Agreement shall continue in force after any termination of this Student License Agreement.

## WARRANTY

Maplesoft warrants to you as original end user, that the physical media on which the Software is recorded is free from defects in materials and workmanship under normal use and service for a period of ninety (90) days (the "Return Period") from the date of delivery to you as evidenced by a copy of the invoice. If such a defect exists and you are within the Return Period, you may return the entire package, including packaging, postage prepaid with a copy of this invoice to Maplesoft at the address below, and Maplesoft, at its option, shall either (a) return the purchase price or (b) replace the media. If failure of the media has resulted from accident, abuse, or misapplication, Maplesoft shall have no responsibility whatsoever to refund the purchase price or replace the media. In the event of replacement of the media, the replacement media will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is the longer. This remedy is your exclusive remedy for a breach of this warranty, and Maplesoft's or any of its affiliated corporations and their respective directors, officers, employees or shareholders (the "Affiliates") entire liability and only warranty made with respect to the Software and Printed Materials. You acknowledge that you have read this Student License Agreement and limited warranty, understood them, and agree to be bound by their terms and conditions. You also agree that this Student License Agreement is the complete and exclusive agreement between you and Maplesoft, and supersedes all prior agreements, representations and any other communications, oral or written, between you and Maplesoft relating to the subject matter of the Student License Agreement including, without limitation, any warranties with respect to the Software and Printed Materials. This Student License Agreement may only be amended by written agreement of both parties.

## EXPORT CONTROLS

The Software and Printed Materials is subject at all times to all applicable export control laws and regulations in force from time to time. You agree that you shall not make any disposition of the Software and Printed Materials purchased or licensed from Maplesoft.

## GOVERNING LAW

This Student License Agreement is governed by the laws of the Province of Ontario, Canada and, if the Software and Printed Materials were acquired within Canada, each of the parties hereto irrevocably agrees to the exclusive jurisdiction of the courts of the Province of Ontario without regard to conflicts of laws principles. If the Software and Printed Material were acquired outside Canada, each of the parties hereto irrevocably agrees to the non-exclusive jurisdiction of the courts of the Province of Ontario, provided that the Licensee agrees that any claim or action brought by the Licensee shall be commenced in the courts of the Province of Ontario. The parties agree that the United Nations Convention on Contracts for the International Sale of Goods does not apply to this License Agreement.

## SUCCESSORS AND ASSIGNS

These terms and conditions inure to the benefit of and shall be binding upon our respective heirs, successors or permitted assigns.

## INVALIDITY OF TERMS

If any of these terms and conditions are found by a court of competent jurisdiction to be invalid, the parties hereto nevertheless agree that the court should endeavour to give effect to the parties' intentions as reflected in such term or condition, and the other terms and conditions shall remain in full force and effect.
